

TRANSCEND MEDICAL PRIVACY POLICY Transcend Medical (the “Company”) is committed to maintaining robust privacy protections for its users. Our Privacy Policy (“Privacy Policy”) is designed to help you understand how we collect, use and safeguard the information you provide to us and to assist you in making informed decisions when using our Service. For purposes of this Agreement, “Site” refers to the Company’s website, which can be accessed at www.transcendmedical.net. “Service” refers to the Company’s services accessed via the Site, in which users can learn about home medical equipment/purchase to purchase. The terms “we,” “us,” and “our” refer to the Company. “You” refers to you, as a user of our Site or our Service. I. INFORMATION WE COLLECT We collect “Non-Personal Information” and “Personal Information.” Non-Personal Information includes information that cannot be used to personally identify you, such as anonymous usage data, general demographic information we may collect, referring/exit pages and URLs, platform types, preferences you submit and preferences that are generated based on the data you submit and number of clicks. Personal Information includes your email, we collect address, date of birth, marital status, contact information, medical information which you submit to us through the registration process at the Site.

1. Information collected via Technology To activate the Service you do not need to submit any Personal Information other than your email address. To use the Service thereafter, you [do/do not] need to submit further Personal Information. 3. Children’s Privacy the Site and the Service are not directed to anyone under the age of 13. II. HOW WE USE AND SHARE INFORMATION Personal Information: Except as otherwise stated in this Privacy Policy, we do not sell, trade, rent or otherwise share for marketing purposes your Personal Information with third parties without your consent. We do

share Personal Information with vendors who are performing services for the Company, such as the servers for our email communications who are provided access to user's email address for purposes of sending emails from us. Those vendors use your Personal Information only at our direction and in accordance with our Privacy Policy. In general, the Personal Information you provide to us is used to help us communicate with you. For example, we use Personal Information to contact users in response to questions, solicit feedback from users, provide technical support, and inform users about promotional offers.
